

#### WHAT TO EXPECT DURING CONSTRUCTION


SECTION A – LANE RESTRICTIONS - DUNDAS ST E/SIDEROAD 15 BETWEEN DANIEL ST AND BOLAND DR

- Traffic will be restricted to one lane along Dundas St E / Sideroad 15 that will allow for traffic flow in both directions. Temporary traffic lights will be installed at the intersection of Tomwell Crescent (West) and at Boland Drive.
- Boland Drive will be closed, access to the Community Center is from Inkster Drive.




#### SECTION B – ROAD CLOSURE – LOCAL TRAFFIC ONLY - DUNDAS ST E / SIDEROAD 15 BETWEEN MAIN ST AND DANIEL ST; DANIEL ST AND BOLAND DR

- Traffic will be required to follow detour routes which will be clearly marked with traffic signs along the approach roads in the work areas. Local traffic for homes and businesses will always be allowed.
- Boland Drive will be closed, access to the Community Center is from Inkster Drive.
- Tomwell Crescent West Entrance will also be closed, access and egress from Tomwell Crescent East Entrance



#### FREQUENTLY ASKED QUESTIONS

#### Will I have access to my property?

Yes, local traffic, emergency vehicles and any clients for the local businesses will always have access.

#### Will there be any water or utility disruptions?

No, we do not anticipate any utility disruption currently. There is a potential for water disruptions when the new watermain from Erinlea Crescent to Tenth Line is being connected. Homeowners affected by this connection will be provided with a notice at a minimum of 48hours prior to any disruptions.

## Will there be any tree removals? If so, what replanting is being done?

No, we do not anticipate any tree removals currently. If this changes, the homeowners will be made aware and will have ample time to express their thoughts and concerns regarding any replanting.

## Will there be any interruptions to mail delivery (Canada Post, Purolator, UPS, etc.)?

No, mail delivery vehicles will be treated as emergency vehicles and will always have access.

## Will there be any interruptions to garbage collection?

No, garbage trucks will be treated as emergency vehicles and will always have access.

#### Will there be a Pre-Condition Survey of my property?

Yes, if your residence is along Dundas St E between Main St and Tenth Line, a notice will be sent by OZA Inspections on behalf of National Properties Inc requesting permission to conduct a Pre-Condition Survey on the property. The Survey (photos and videos) is not limited to the buildings, but will include garages, sheds, driveways, retaining walls, fences, patios, walkways, porches, landscaping, and any other improved surfaces.



- Erindale Dr will be closed, access and egress from Erinlea Crescent








